## MISSION REPORT

# Regional Public Information Campaign and Training Activities of the Occupational Safety and Health Center in Region 7 March 6-10, 2005

## **BACKGROUND**

To sustain the activities on OSH in Region 7 and as an output of the regional visit on January 24-28, 2005, the OSHC strengthened partnerships with organizations based in Bohol and Cebu resolved to sign MOAs with different organizations, and with partner agencies in work safety and health. Dr. Dulce Gust headed the OSHC team in Cebu.

## **OUTPUT**

The activities in Cebu and Bohol from March 6-10, 2005, resulted in the following:

- 1.OSHC signed a MOA with the ALU-TUCP, Bohol Association of Hotels, Resorts and Restaurants (BAHRR), Bohol Chamber of Commerce and Industry (BCCI).
- 2. The MOA cover joint undertakings in terms of information dissemination activities; training programs; implementation of the Zero Accident Program in the region, search for Gawad Kaligtasan at Kalusugan nominees; and sustainability of programs and projects that stresses on including OSH in the regular activities of the organization (annex 1, 2, 3).
- 3. In an effort to assist the safety organizations in Cebu that would eventually expand the base of OSH trainors and advocates in the region, OSHC held a meeting with SOPI-Cebu which has around 100 members to date. Among the issues raised by SOPI-Cebu and responses or agreements reached during the meeting were:

4. OSHC also held a separate meeting with the Mactan Export Zone (MEZ) Safety and Security Council which has about 85 members to date. Established in 1997, it has yet to be accredited as a safety organization but has plans to do such in the near future. Among the issues raised by the MEPZ Council were:

- 4. Members of the mass media were very supportive of all the OSH activities DOLE-RO 7 and OSHC officials were invited to guest in seven radio programs like DYLA, DYAB, Bombo Radyo, DYRF, DYRM, among others.
- 6. Simultaneous with these activities were the trainings on work-relatedness of diseases by OSHC for ALU-TUCP doctors and workers. (Please refer to Annex 4 for the names of the participants, and Annex 5 for the outline of the syllabus)

# RECOMMENDATIONS/CONCLUSION

We therefore recommend the following strategies and activities to sustain preventive OSH work in Region 7

- Conduct the trainings SOPI-Cebu and the MEZ Council requested, with specific focus on the training of trainors;
- To complete a feasibility study on establishing an mini-OSH Center or an OSH office within the DOLE Regional Office by October 2005 for program planning in 2006.

 Hold a forum during the celebration of the World Day for Safety and Health at Work on April 28, 2005 to capture a larger audience that could be future partners on OSH to sustain activities in the region;

 To have a MOA with SOPI-Cebu and the MEZ Council or other partners in Cebu
